## **1.0** DUTIES AND RESPONSIBILITIES

Mechanics are required to perform a range of duties and responsibilities that can differ from day to day depending on the jobs that they are assigned. This can include anything from troubleshooting, repairing, and moving heavy pieces of machinery. Typical tasks include disassembling equipment to locate the issue and then reassembling. Also knowing how to test and calibrate machinery to ensure it is operating at maximum efficiency.

# 1.1 Specific responsibilities

- Handles repair work, maintenance, preventive work and overhauls engines.
- Sustains proper maintenance and repairs of hydrostatic fluid pumps
- Running diagnostics, visual inspection and troubleshooting our operations to minimize issues and downtime.
- Always follow safe work practices and familiarize self with JSA's.
- Maneuver location safely and know where hazard is.
- Contact supervisor or management if employee concerns arise.
- Continued support to Supervisor and Management.
- Responsible for reading and interpreting documents such as safety rules, operating and maintenance manuals, and procedure manuals.
- Maintain work area clean and organized.
- Traveling may be required as needed.
- Other tasks as assigned.

# 1.3 Skills and Abilities

- Ability to interpret equipment repair manuals.
- Ability to communicate fluently in English (written and verbally)
- Ability to perform job duties in a rapidly changing environment with competing priorities and sometimes under stress.
- Thorough knowledge of well opening sequence procedure to bring a well online.
- Able to repair all trim and seats on dump valves and back pressure regulators.
- Capable of trouble shooting measurement equipment.
- In depth understanding of the flow path from the well head to the separation equipment.
- Able to create and execute an evacuation plan.
- Ability to apply common sense understanding to carry out instructions furnished in written, oral, or diagram form.



**2.0** PHYSICAL AND SAFETY REQUIREMENTS

- Can lift and carry up to 100 lbs max
- Ability to climb a ladder
- Able to do a 50-lb overhead lift
- Repetitive turning, like a choke wheel or well head valve
- Ability to climb in and out of truck's cab
- Able to swing 8 lb sledge hammer
- Sitting, bending, standing, walking, and typing 12 hours per day.
- Pass the required physical examination and drug screen as well as a Motor Vehicle Record check.
- Able to work in weather elements day or night time
- The employee must be adaptable to the unique work conditions that consist of long and irregular hours and changes in locations of work assignments. This position requires working in the field setting majority of the time with various weather conditions consisting of: wet, cold, and/or humid conditions at well sites, working near moving mechanical parts, vibration, loud noise, potential fumes or airborne particles, exposure to toxic or caustic chemicals where proper PPE must be donned.
